## **SECTION IV** (Fire & Explosion Data)

#### **SECTION V** (First Aid Measures)

IF SWALLOWED: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water & induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear.

IF IN EYES: Flush with plenty of water. Get medical attention if irritation persists.

IF ON SKIN OR CLOTHING: Remove contaminated clothing & wash before re-use. Wash skin with soap & warm water. Get medical attention if irritation persists.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if needed.

Absorb in sawdust or sand & dispose of properly.

# SECTION VII (Handling, Storage & Disposal)

DO NOT CONTAMINATE WATER, FOOD OR FEED BY STORAGE OR DISPOSAL. *HANDLING:* Wear rubber gloves. Do not inhale spray. *STORAGE:* Store in cool, dry area away from heat or open flame. *DISPOSAL:* Wrap container in several layers of newspaper and discard in trash. DO NOT PUNCTURE! ## SECTION IX (Precautionary Statements-Hazards to Humans & Domestic Animals)

Harmful if swallowed, absorbed through the skin or inhaled. Avoid contact with skin, eyes or clothing. Avoid breathing spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

Do not spray in or towards the eyes, affected areas around the eyes should be treated with care to avoid getting the product into the eyes. To prevent reinfestation, change bedding daily. Wash bedding thoroughly after use.
